The students of French 1010, will study to acquire A2 level competency necessary for communication in various real-life domains which include the following:

human relations; description of people (both physical and characterial), objects, places and experiences in the past; daily life; personal and professional plans and projects to be realized in the future; health and well-being; current political and social issues. The student is expected to achieve A2 level linguistic competency with respect to the following:

### **Grammaire:**

#### **grammatical gender and number:**

*masculin, féminin, singulier, pluriel: formes régulières et irrégulières;*

#### **grammatical functions:**

*sujet, attribut, complément d'objet direct, complément d'objet indirect, complément circonstanciel;*

#### **superlative:**

*superlatif de noms, d'adjectifs, de verbes, d'adverbes;*

#### **verb tenses and types:**

*imparfait et futur simple de l'indicatif; présent du conditionnel et du subjonctif;*

*présent et passé des verbes pronominaux ;*

#### **pronouns:**

*pronoms personnel adverbiaux; pronoms personnels disjoints, pronoms relatifs;*

#### **adverbs:**

*formation des adverbes de manière; adverbes de négation;*

#### **prepositions:**

*prépositions + infinitif;*

#### **conjunctions:**

*conjonction de subordination "que" ;*

### **Sentence structure (syntax):**

*phrases simples: déclaratives affirmatives, déclaratives négatives, interrogatives, impératives, exclamatives;*

*phrases complexes coordonnées; proposition infinitive;*

*phrase complexe: proposition principale; proposition subordonnée conjonctive, relative adverbiale;*

### **Vocabulary:**

vocabulary of human relations, of remembered childhood events, of traditions, of travels; vocabulary of daily life, of physical activities; vocabulary of clothing, of leisure activities; vocabulary of professional life, of health and well-being; vocabulary of selected contemporary political and social issues;

## Phonetics:

*dans la lecture à haute voix de longs textes, le perfectionnement de la prononciation des consonnes, des voyelles orales et nasales et des semi-voyelles; perfectionnement de la prononciation de la liaison, de l'élision, de l'enchaînement vocalique et consonantique; perfectionnement de l'intonation, de l'accent; perfectionnement de la réalisation de "e" caduc, de "h" muet et de "h" aspiré;*

### **Overview of Class and Laboratory Manual Work:**

classroom work involves note taking, regular readings, oral group and individual exercises of application, as well as written exercises. In class, students will do exercises and activities individually, with partners and in groups. The laboratory manual component consists essentially of oral, and aural elements, i.e. French language content mediated primarily through oral activities.

### **Classroom Attendance:**

Regular attendance, and active participation in class are necessary ingredients for success. Attendance is recorded. It is important to arrive on time and to stay to the end of class. Please advise your professor in case of unavoidable absences, such as illness or family emergencies and be prepared to provide documentation.

### **Laboratory Manual - Particulars:**

Selected listening comprehension, and pronunciation exercises will be assigned to students. These exercises entail the use of both the *Mais oui! laboratory manual*, which constitutes a section of the *Student Activities Manuel*, and the *Mais oui!* computer code which gives students access to on-line exercises on the *Mais oui!* site. Work done in this component of the course will be submitted, in the form of an assignment, at the end of the course.

### **Tests:**

There are 2 written tests based on the material in the textbook studied in class - for dates, see "Assignment Timetable/Emploi du Temps des Devoirs". Requests to write a make-up test will be granted only in serious circumstances upon submission of documentation. Prior notification of the professor, where possible, of an absence during a scheduled test is required before permission to write a make-up test is given.

### Written Assignments:

There are 5 such assignments (5 assignments related to 5 of the 6 chapters studied in the textbook), each consisting of selected workbook exercises based on chapters 8-12 of the textbook. These assignments must be submitted by the due date, failing which a penalty of – 2% per day is imposed up to a maximum of 10% (5 school days, after which assignments will not be accepted).

Most of the answers to the questions posed in the exercises are made available to the students in the form of “answer keys” found on the Fr 1010 section 530 course site in Western’s course delivery platform *Sakai*, or provided in print form. What is required of each student is that he or she submit all original answers, **as well as corrections** made to the latter, should errors be made. Marks will not be deducted for incorrect original answers; **marks will be deducted**, however, **if exercises are incomplete, not done, or consistently and extensively done incorrectly**, the latter state of affairs indicating the student’s fundamental incomprehension of the language point(s) at issue.

**\*\*Important note:**

**Since the students will themselves do the checking and correcting of their answers, it is imperative that this work be done conscientiously and very thoroughly; imperative also, it goes without saying, that the students not merely copy the correct answers, and submit their assignments with answers which are not their own, and which they do not necessarily understand.** The students who do the preceding, will not only have committed a grave academic infraction, but will also be at a serious disadvantage when they write their 2 tests ( $2 \times 15\% = 30\%$ ), and their final exam (30%).

For some of the exercises, the answer key bears the indication “Answers will vary”, “Possible answers” and “Suggested answers”. The answers given here are not the only correct answers. For such exercises, as is the case with the others mentioned above, no marks are deducted for original incorrect answers; however, if it is evident that students have merely copied the suggested or possible answers found in the answer key, a penalty is imposed.

### Final Examination:

There is a 3 hour final exam following soon after the last day of class.

### 1. display the communication competency by being able to:

- demonstrate understanding and mastery of some basic grammatical concepts;
- apply new vocabulary, grammar and pronunciation to various communication situations;
- apply their knowledge and skills in oral and written comprehension and production in simple authentic communication situations;
- contribute to conversation by offering personal comments that are relevant;

### 2. demonstrate the Inquiry, and Analysis and Information Literacy competencies by being able to:

- evaluate evidence to identify patterns, differences, similarities, limitations, implications, etc. and relate a particular case to a general (grammatical, phonetic) rule;
- analyze their own limitations and weaknesses; find the appropriate available information (in dictionary, grammar books, internet, etc.) to complement and develop knowledge and skills;
- seek help when needed (ask questions of the professor, go to the writing center, etc.);
- compare different strategies for personally managing and mastering information.

### 1. POLICY REGARDING ACADEMIC ACCOMMODATION

Students who have long-term or chronic medical conditions which may impede their ability to complete academic responsibilities should seek Academic Accommodation through Student Accessibility Services ([http://www.westerncalendar.uwo.ca/PolicyPages.cfm?PolicyCategoryID=1&Command=showCategory&SelectedCalendar=Live&ArchiveID=#Page\\_10](http://www.westerncalendar.uwo.ca/PolicyPages.cfm?PolicyCategoryID=1&Command=showCategory&SelectedCalendar=Live&ArchiveID=#Page_10)).

Personal commitments (e.g., vacation flight bookings, work schedule) which conflict with a scheduled test, exam or course requirement are **not** grounds for academic accommodation.

Students who experience an illness or extenuating circumstance sufficiently severe to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

1. Submitting a **Self-Reported Absence** form provided that the conditions for submission are met;
2. For medical absences, submitting a **Student Medical Certificate (SMC)** signed by a licensed medical or mental health practitioner;
3. For non-medical absences, submitting **appropriate documentation** (e.g., obituary, police report, accident report, court order, etc.) to their Academic Advisor. Students are encouraged to contact their Academic Advisor to clarify what documentation is acceptable.



## Requests for Academic Consideration Using the Self-Reported Absence Portal

Students who experience an unexpected illness or injury or an extenuating circumstance of 48 hours or less that is sufficiently severe to render them unable to meet academic requirements should self-declare using the online Self-Reported Absence portal. This option should be used in situations where the student expects to resume academic responsibilities within 48 hours. Note that the excused absence includes all courses and academic requirements within the up to 48 hours, it is not intended to provide an excused absence from a single course while students fulfill their academic responsibilities in other courses during that time.

The following conditions are in place for self-reporting of medical or extenuating circumstances:

1. Students will be allowed **a maximum of two self-reported absences** between September and April and one self-reported absence between May and August;
2. The duration of the absence will be for a maximum of 48 hours from the time the Self-Reported Absence form is completed through the online portal, or from 8:30 am the following morning if the form is submitted after 4:30 pm;
3. The excused absence will terminate prior to the end of the 48 hour period if the student undertakes significant academic responsibilities (writes a test, submits a paper) during that time;
4. Self-reported absences will **not** be allowed for scheduled final examinations; midterm examinations scheduled during the December examination period; or for final lab examinations scheduled during the final week of term;
5. Self-report absences may **not** be used for assessments worth more than 30% of any course;
6. Any absences in excess of 48 hours will require students to present a Student Medical Certificate (SMC), or appropriate documentation;
7. Students **must** communicate with their instructors **no later than 24 hours after the end of the period covered by the Self-Reported Absence form** to clarify how they will fulfill the academic expectations they may have missed during the absence.

## Request for Academic Consideration for a Medical Absence

When a student requests academic accommodation (e.g., extension of a deadline, a makeup exam) for work representing 10% or more of the student's overall grade in the course, it is the responsibility of the student to provide acceptable documentation to support a medical or compassionate claim. All such requests for academic accommodation **must** be made through an Academic Advisor and include supporting documentation.

Academic accommodation for illness will be granted only if the documentation indicates that the onset, duration and severity of the illness are such that the student could not reasonably be expected to complete their academic responsibilities. Minor ailments typically treated by over-the-counter medications will not normally be accommodated.

The following conditions apply for students seeking academic accommodation on medical grounds:

1. Students must submit their Student Medical Certificate (SMC) along with a request for relief specifying the nature of the accommodation being requested no later than two business days after the date specified for resuming responsibilities. An SMC can be downloaded from [http://www.uwo.ca/univsec/pdf/academic\\_policies/appeals/medicalform.pdf](http://www.uwo.ca/univsec/pdf/academic_policies/appeals/medicalform.pdf) ;
2. In cases where there might be an extended absence or serious issue, students should submit their documentation promptly and consult their Academic Advisor for advice during their recovery period;
3. Whenever possible, students who require academic accommodation should provide notification and documentation in advance of due dates, scheduled tests or examinations, and other academic requirements;



4. Students **must** communicate with their instructors **no later than 24 hours** after the end of the period covered by the SMC to clarify how they will fulfil the academic expectations they may have missed during the absence;
5. Appropriate academic accommodation will be determined by the Dean's Office/Academic Advisor in consultation with the course instructor(s). Academic accommodation may include extension of deadlines, waiver of attendance requirements, arranging Special Exams (make-ups), re-weighting course requirements, or granting late withdrawal without academic penalty.

## 2. ACADEMIC CONCERNS

If you feel that you have a medical or personal challenge that is interfering with your work, contact your instructor and Academic Advisor as soon as possible. Problems may then be documented and possible arrangements to assist you can be discussed at the time of occurrence rather than on a retroactive basis. Retroactive requests for academic accommodation on medical or compassionate grounds are not normally considered.

If you think that you are too far behind to catch up or that your work load is not manageable, you should consult your Academic Advisor. If you consider reducing your workload by dropping one or more courses, this must be done by the appropriate deadlines; please refer to the [Registrar's website](http://brescia.uwo.ca/academics/registrar-services/), <http://brescia.uwo.ca/academics/registrar-services/> or the list of official sessional dates in the Academic Calendar (<http://www.westerncalendar.uwo.ca/SessionalDates.cfm?SelectedCalendar=Live&ArchiveID=>).

You should consult with the course instructor and the Academic Advisor who can help you consider alternatives to dropping one or more courses. *Note that dropping a course may affect OSAP eligibility and/or Entrance Scholarship eligibility.*

## 3. ABSENCES

**Short Absences:** If you miss a class due to a minor illness or other problems, check your course outline for information regarding attendance requirements and make sure you are not missing a test or assignment. Cover any readings and arrange to borrow notes from a classmate. Contact the course instructor if you have any questions.

**Extended Absences:** If you have an extended absence, you should contact the course instructor and an Academic Advisor. Your course instructor and Academic Advisor can discuss ways for you to catch up on missed work, and arrange academic accommodations if appropriate and warranted.

It is important to note that the Academic Dean may refuse permission to write the final examination in a course if the student has failed to maintain satisfactory academic standing throughout the year or for too frequent absence from the class or laboratory ([http://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID=5&SelectedCalendar=Live&ArchiveID=#SubHeading\\_68](http://www.westerncalendar.uwo.ca/PolicyPages.cfm?Command=showCategory&PolicyCategoryID=5&SelectedCalendar=Live&ArchiveID=#SubHeading_68) ).

## 4. SCHOLASTIC OFFENCES

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offences. Note that such offences include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. Students are advised to consult the section on Scholastic Discipline for Undergraduate Students in the Academic Calendar.

If you are in doubt about whether what you are doing is inappropriate or not, consult your instructor, the Academic Dean's Office, or the Registrar. A claim that "you didn't know it was wrong" is not accepted as an excuse.

The penalties for a student guilty of a scholastic offence (including plagiarism) include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

#### **Plagiarism:**

Students must write their essays and assignments in their own words. Whenever students take an idea or a passage from another author, they must acknowledge their debt both by using quotation marks where appropriate and by proper referencing such as footnotes or citations. Plagiarism is a major academic offence.

All required papers may be subject to submission for textual similarity review to the commercial plagiarism detection software under license to the University for the detection of plagiarism. All papers submitted for such checking will be included as source documents in the reference database for the purpose of detecting plagiarism of papers subsequently submitted to the system. Use of the service is subject to the licensing agreement, currently between The University of Western Ontario and Turnitin.com (<http://www.turnitin.com>).

#### **Computer-marked Tests/exams:**

Computer-marked multiple-choice tests and/or exams may be subject to submission for similarity review by software that will check for unusual coincidences in answer patterns that may indicate cheating. Software currently in use to score computer-marked multiple-choice tests and exams performs a similarity review as part of standard exam analysis.

## **5. PROCEDURES FOR APPEALING ACADEMIC EVALUATIONS**

All appeals of a grade must be directed first to the course instructor. If the student is not satisfied with the decision of the course instructor, a written appeal is to be sent to the School Chair. If the response of the Chair is considered unsatisfactory to the student, they may then submit a written appeal to the Office of the Dean. If the student is not satisfied with the decision of the Dean, they may appeal to the Senate Review Board Academic (SRBA), if there are sufficient grounds for the appeal and if the matter falls within the jurisdiction of the SRBA. Note that final course marks are not official until the Academic Dean has reviewed and signed the final grade report for the course. If course marks deviate from acceptable and appropriate standards, the Academic Dean may require grades to be adjusted to align them with accepted grading practices.

## 6. PREREQUISITES

Unless you have either the prerequisites for a course or written special permission from the Dean to enroll in it, you will be removed from the course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisite(s).
